SCHOLARSHIP INFORMATION:

The Mills County Chamber of Commerce is accepting applications for two \$250 education incentives to be awarded to students who are graduating seniors attending high school in Mills County.

ELIGIBILITY REQUIREMENTS:

To be considered for a Mills County Chamber of Commerce Education Incentive, an applicant **must**:

- ❖ be a high school graduating Senior.
- ❖ attend a high school in Mills County and be a graduating senior in 2018.
- ❖ have applied for admission as a full-time student at a vocational school, technical school, junior college or university.

RECIPIENT REQUIREMENTS:

- ❖ Recipient must currently have at least a 3.00 cumulative grade point average on 4.00 scale.
- ❖ Recipient must be enrolled in full-time courses (12 semester hours) at institution of higher education.
- ❖ Funds not disbursed within the 2018-2019 school year will be forfeited.

APPLICATIONS MUST INCLUDE ALL OF THE FOLLOWING TO BE REVIEWED AND CONSIDERED:

1. A completed Mills County Chamber of Commerce Education Incentive Program Application.
2. List of community/additional activities.
3. Applicant's narrative (***LESS THAN 500 WORDS***).

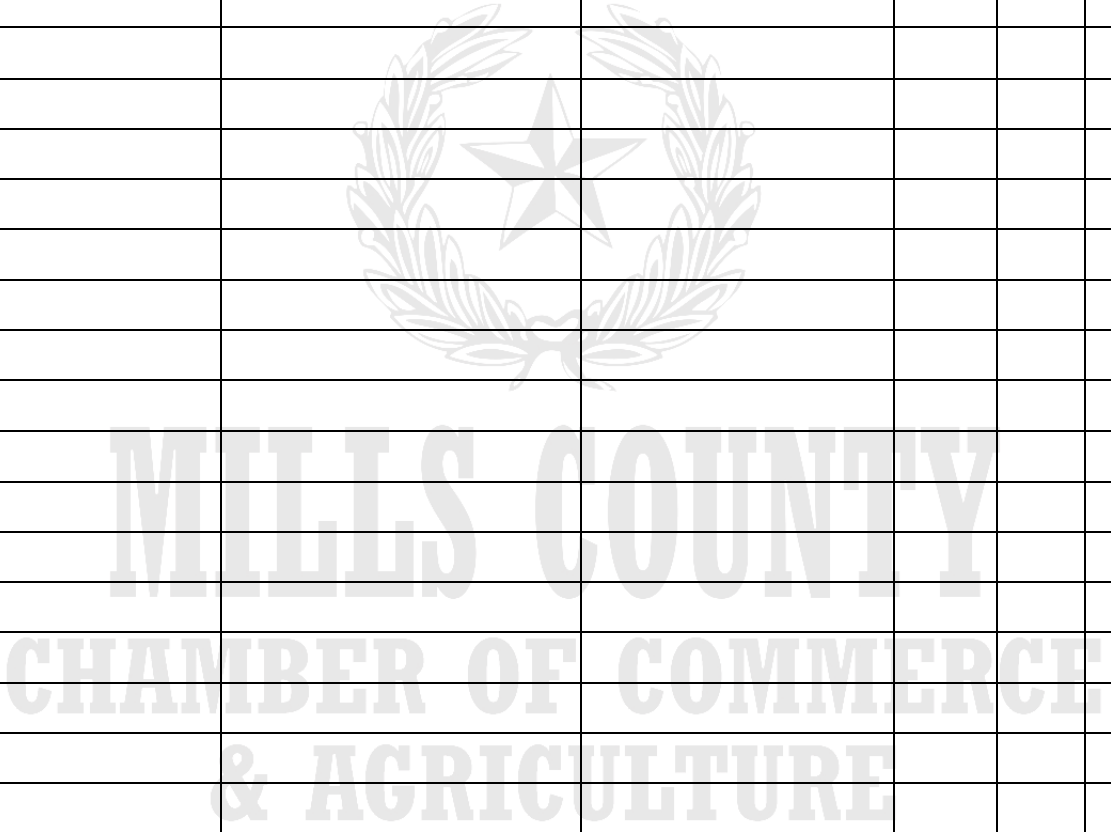

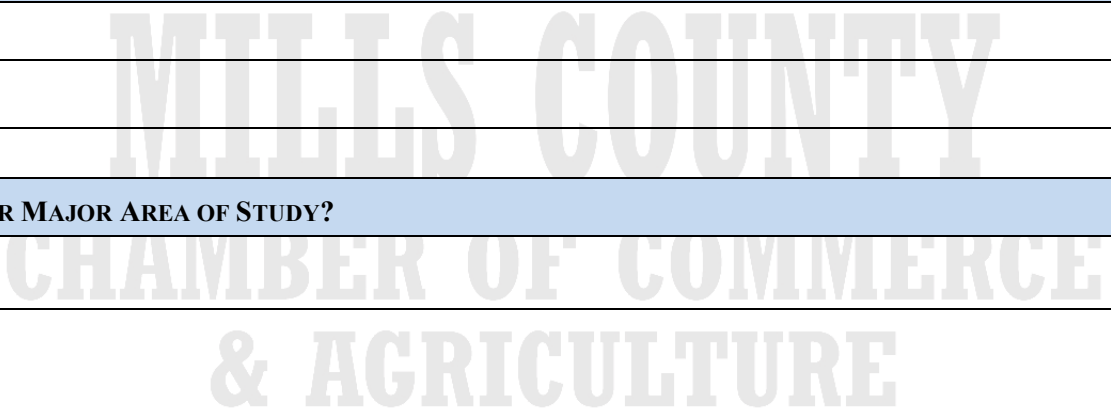
